<u>Work Summary</u>: Town seeks services related to the purchase and installation of wrought iron fence and gates at Town Square. The services are required to be completed within 90 days of the Notice to Proceed or Purchase Order as applicable. The services are generally described as follows: Furnish and install wrought iron fences and gates including gate controller and loops at locations shown on the plans and required signage to be located in and around Town Square. The workmanship will be prescribed by special specification, in conformity with details shown on the plans and/or as directed/approved by the Public Works Manager.

The Town intends to purchase wrought iron fencing and gates in compliance with these specifications.

#### I. REQUIREMENTS FOR PROPOSERS.

- 1.1 <u>Proposal Opening Date and Location:</u> Proposals will be received in the office of the Town Clerk, 12030 North Clubhouse Square, Youngtown Arizona 85363, until 1:00 p.m., on October 18, 2018, at which time the names of the proposers will be opened and publicly read. Proposal prices will not be read. Late proposals will not be considered.
- 1.2 <u>Proposal Documents Available:</u> The Proposal Documents consist of four parts: I. Requirements for Proposers, II. General Conditions, III. Scope of Work, and IV. Proposer's Proposal (form). The Proposal Documents are available at the Town of Youngtown Clerk's Office, 12030 North Clubhouse Square, Youngtown Arizona 85363; or by contacting Marty Mosbrucker, Public Works Manager, telephone no. 623-933-8286, and may be obtained upon request.
- 1.3 <u>Incorporation of Proposal Documents:</u> All of the Proposal Documents apply to and become a part of the terms and conditions of the proposal.
- 1.4 <u>Proposal Form:</u> Proposals must be submitted only on the proposal form. All proposals must be submitted in a sealed envelope clearly marked "Proposal for Town Square Wrought Iron Fence and Gates Office of the Town Clerk."
- 1.5 <u>Town's Right to Reject Proposals:</u> The Town of Youngtown reserves the right to reject any and all proposals and to waive technicalities.
- 1.6 <u>Late Proposals</u>: Late submittals and/or unsigned Proposals will not be considered under any circumstances. Envelopes containing Proposals with insufficient postage will not be accepted by the Town. It is the sole responsibility of the Proposer to see that his/her Proposal is delivered and received by the proper time and at the proper place.
- 1.7 <u>Proposal Amendment or Withdrawal</u>: A Proposal may be withdrawn any time before the Proposal due date and time. A Proposal may not be amended or withdrawn after the Proposal due date and time except as otherwise provided by applicable law.
- 1.8 <u>Public Record</u>: All Proposals submitted in response to this solicitation and all evaluation related records shall become property of the Town and shall become a matter of public record for review, subsequent to proposal opening. Request for nondisclosure of data such as trade secrets and other proprietary data, must be made known in writing to the Town in Proposals submitted, and the information sought to be protected clearly marked as proprietary. The Town will not insure confidentiality of any portion of the proposal that is submitted in the event that a public record request is made. The Town will provide 48 hours' notice before releasing materials identified by the proposal as confidential or proprietary in order for the proposer to apply for a court order blocking the release of the information.

- 1.9 <u>Persons with Disabilities</u>: Persons with a disability may request a reasonable accommodation, such as a sign language interpreter, by contacting the Clerks' Office. Requests shall be made as early as possible to allow time to arrange the accommodation.
- 1.10 <u>Proposal Acceptance Period</u>: All proposals shall remain open for 2 days after the day of the opening of proposals, but the Town may, at its sole discretion, release any proposal and return the proposal security (as applicable) prior to that date. No Proposer may withdraw his Proposal during this period without written permission from the Town. Should any Proposer refuse to enter into a contract, under the terms and conditions of the procurement, The Town may retain the security (as applicable), not as a penalty, but as liquidated damages.
- 1.11 <u>Addendum</u>: This Request for Proposals may only be modified by a written Addendum. Potential Proposers are responsible for obtaining all addenda.
- 1.12 <u>Proposer Registration</u>: Proposers shall register via email at <u>mmosbrucker@youngtownaz.org</u>, in order to automatically receive notification of Addenda to this Solicitation or notice of other solicitation opportunities. - 1.13 <u>Proposal Bond:</u> Each Proposal will be submitted on the Proposal Form(s) included in the Contract Documents and will be accompanied by a certified check, cashier's check, or proposal bond for ten percent (10%) of the amount of the proposal, made payable to the Town of Youngtown.

#### 1.14 General Evaluation Standards:

- 1.14.1 The Town of Youngtown seeks to obtain the services described above in the Scope of Work. The Town will evaluate proposals on the selection criteria set forth below. The Town will be the sole judge of whether the services offered are acceptable. Proposals from individuals who have provided inadequate services to municipalities in the past, or proposals offering services proven unsatisfactory in the Town's sole judgment may be rejected and not considered.
  - A. Firm Experience and Capability
  - B. Expertise of Firm's Key Staff
  - C. Local Firm Consideration
  - D. Prior Projects with Town
  - E. Other Prior Projects

- 1.14.2 Town reserves the right to reject any or all proposals or any part thereof, or to accept any proposal, or any part thereof, or to withhold the award and to waive or decline to waive irregularities in any proposal when it determines that it is in its best interest to do so.
- 1.14.3 A Proposer (including each of its principals) who is lawfully prohibited from any public procurement activity may have its Proposal rejected.
- 1.14.4 <u>Clarifications</u>. The Town reserves the right to obtain Proposer clarifications where necessary to arrive at full and complete understanding of Proposer's

product, service, and/or solicitation response. Clarification means a communication with a Proposer for the sole purpose of eliminating ambiguities in the Proposal and does not give Proposer an opportunity to revise or modify its proposal.

1.14.5 <u>Waiver and Rejection Rights.</u> The Town of Youngtown reserves the right to reject any or all Proposals or to cancel the solicitation altogether, to waive any informality or irregularity in any Proposal received, and to be the sole judge of the merits of the respective Proposals received.

#### 1.15 Proposal Preparation:

- 1.15.1 Format. Proposers shall submit their Proposal with an original and two (2) copies and shall be submitted either on the forms provided in this Solicitation or their substantial equivalent. Any substitute document must be legible and contain the same information requested on the forms.
- 1.15.2 <u>No Facsimile or Electronic Mail Proposals</u>. Proposals may not be submitted in facsimile or electronically. A facsimile or electronic mail Proposal shall be rejected.
- 1.15.3 <u>Typed or Ink Corrections</u>. The Proposal shall be typed or in ink. Erasures, interlineations or other modifications in the Proposal shall be initialed in ink by the person signing the Proposal.
- 1.15.4 <u>No Modifications</u>. Modifications shall not be permitted after Proposals have been opened except as otherwise provided under applicable law.
  - 1.15.5 Content. The Proposal shall contain all of the following information:

- 1.15.6 Solicitation Addendum Acknowledgement. Each Solicitation Addendum shall be acknowledged in the Proposal Section, which shall be submitted together with the Proposal on the Proposal due date and time. Failure to note a Solicitation Addendum may result in rejection of the Proposal.
- 1.15.7 Evidence of Intent to be Bound. The Proposal form within the Solicitation shall be submitted with the Proposal and shall include a signature by a person authorized to sign the Proposal. The signature shall signify the Proposer's intent to be bound by its Proposal and the terms of the Solicitation and that the information provided is true, accurate and complete. Failure to submit verifiable evidence of intent to be bound, such as an original signature, shall result in rejection of the Proposal.
- 1.15.8 Non-Collusion and Non-Discrimination. By signing and submitting the Proposal, the Proposer certifies that: the Proposer did not engage in collusion or other anti-competitive practices in connection with the preparation or submission of its Proposal; and the Proposer does not discriminate against any employee or applicant for employment or person to whom it provides services because of race, color, religion, age, sex, national origin, or disability, and that it complies with all applicable Federal, state and local laws and executive orders regarding employment.

### 1.16 <u>Inquiries</u>:

- 1.16.1 <u>Duty to Examine</u>. It is the responsibility of each Proposer to examine the entire Solicitation, seek clarification (inquiries), and examine its Proposal for accuracy before submitting the Proposal. Lack of care in preparing a Proposal shall not be grounds for modifying or withdrawing the Proposal after the Proposal due date and time, nor shall it give rise to any Contract claim.
- 1.16.2 <u>Contact Person</u>. Any inquiry related to a Solicitation, including any requests for or inquiries regarding standards referenced in the Solicitation should be directed solely to the Contact person listed on the cover page of the solicitation. The Proposer shall not contact or direct inquiries concerning this Solicitation to any other Town employee unless the Solicitation specifically identifies a person other than the Contact Person as a contact.
- 1.16.3 <u>Submission of Inquiries</u>. All inquiries except those at the Pre-Proposal Conference shall be submitted in writing and shall refer to the appropriate Solicitation number, page and paragraph. Do not place the Solicitation number on the outside of the envelope containing that inquiry, since it may then be identified as a Proposal and not be opened until after the Proposal due date and time. The Town shall consider the relevancy of the inquiry but is not required to respond in writing.
- 1.16.4 <u>Timeliness</u>. Any inquiry or exception to the solicitation shall be submitted as soon as possible and should be submitted at least ten (10) days before the Proposal due date and time for review and determination by the Town. Failure to do so may result in the inquiry not being considered for a Solicitation Addendum.
- 1.16.5 No Right to Rely on Verbal Responses. A Proposer shall not rely on verbal responses to inquiries. A verbal reply to an inquiry does not constitute a modification of the Solicitation.

#### II. GENERAL CONDITIONS

2.1 <u>Contract Term; Renewal</u>. If funds for this Contract are not appropriated or budgeted, Town may terminate this contract by giving written notice to Contractor. Otherwise, the Contract commences upon execution of the Contract. Services shall not commence until issuance of a Notice to Proceed or Purchase Order by the Town. All services shall be completed by March 1, 2019. Any intermediate deadlines or milestones are set forth in Exhibit C.

#### 2.2 Bonds:

2.2.1 <u>Bonds Required.</u> Concurrently with the execution of the Contract, the Contractor shall furnish the Town the following Bonds, which shall become binding upon the award of the Contract to the Contractor:

A Performance Bond in an amount equal to ten percent (10 %) of the Contract amount conditioned upon the faithful performance of the Contract in accordance with Plans, Specifications and Conditions thereof. Such Bond shall be solely for the protection of Town.

A Payment Bond in an amount equal to ten percent (10 %) of the Contract amount solely for the protection of the claimants supplying labor or materials to the Contractor or his subcontractors in the prosecution of the Work provided for in such Contract.

- 2.2.2 Form. Bond forms to be executed are included with the Contract Documents. Each such Bond shall include a provision allowing the prevailing party in a suit on such Bond to recover as a part of this judgment such reasonable attorney's fees as may be fixed by a judge of the court. Each such bond shall be executed by a surety company or companies holding a certificate of authority to transact surety business in the State of Arizona issued by the Director of the Department of Insurance pursuant to Title 20, Chapter 2, Article 1 of the Arizona Revised Statutes and any amendments thereto. The Bonds shall be made payable and acceptable to the Town. The Bonds shall be written or countersigned by an authorized representative of the surety who is either a resident of the State of Arizona or whose principal office is maintained in this State and the Bonds shall have attached thereto a certified copy of the Power of Attorney of the signing official.
- 2.2.3 <u>Contingent Award.</u> Submittal of the required bonds as set forth in this paragraph is a condition precedent to this contract becoming effective.
- 2.3 <u>Cooperative Use of Contract:</u> Upon written approval of the Successful Proposer and Town, this Contract may be tendered for use by other municipalities and government agencies.

#### III. SCOPE OF WORK

3.1 Furnish and install wrought iron fences and gates including gate controller and loops at locations shown on the plans as well as required signage. The workmanship will be prescribed by this special specification, in conformity with details shown on the plans and/or as directed/approved by the Public Works Manager.

Materials. Furnish new materials in accordance with the details shown on the plans. The materials for the fence include 16-inch x 8-inch masonry columns, rails, columns caps and all necessary fittings and appurtenances required for proper installation. The materials for the gate will be gate controllers, loops and all necessary fittings and appurtenances required for the installation of the gate. The material for the communication cables will meet all the requirements of NEC and be a minimum of AWG No. 22 and meet or exceed the specification of CAT 5 cables. The Contractor will provide the Public Works Manager with the specifications of all items for the fence and gates for approval before installation. See Exhibit 2, samples of the gate and fencing being requested.

The Town is requesting a bid to install an automated remote controlled/keypad operated gate to the employee parking area along with a personnel gate with key pad.

3.3 <u>Construction.</u> Before work commences in the area, the Contractor will inform and inspect the site with the Public Works Manager. After the construction is complete, the Contractor will again inspect the site with the Public Works Manager for approval.

All the material for the new wrought iron (16 gauge with 3/8" pattern) fence panels will be first approved by the Public Works Manager. The new fence will include but not be limited to columns, stucco paint, skip trowel and smooth finish. The concrete footing for the new columns will be as shown on the plans and/or as directed by the Public Works Manager.

Painting will be by hand or spray. Two coats will be required on all parts. The final surface will be of even color without streaks, drips, bubbles, incomplete coverage or any other surface imperfection.

If necessary, the fence will be reinforced at the joints with either welding or welded on metal that will not detract from the decorative appeal of the fence. All welding will be performed in a workman-like manner with solid joints of minimum protrusion. The completed fence will be solid and have minimal flexure. Any excessive splatter of the weld will be ground off.

The Contractor will install a new manual gate(s) and all necessary fittings and appurtenances as shown on the plans and/or as directed by the Public Works Manager.

The Contractor will pull through new conduit without splicing all necessary communication cables from card reader into the control center as shown on the plans and/or as directed by the Public Works Manager.

The Contractor shall provide/install "Public Parking" sign per Exhibit "1".

The Contractor to provide/install "Employee Only Parking" sign at the automated remote control/key pad Operated gate per Exhibit "A".

The Contractor shall provide/install "Deliveries Only" sign per Exhibit "1".

The Contractor shall provide/install a "Do Not Enter" sign per Exhibit "1".

The Contractor shall provide/install a "One Way" sign per Exhibit "1".

3.4 **Measurement.** The installation of new fence panels shall be eight feet wide and or adjusted per the site conditions. The columns shall be placed on eight-foot centers and adjust per site conditions.

#### IV. PROPOSER'S PROPOSAL

- 4.1 <u>Proposer's Proposal:</u> For the proposal opening October 18, 2018 for services.
- 4.2 <u>Covenant Clause:</u> It is expressly agreed by Proposer that these covenants are irrevocable and perpetual.
- 4.3 <u>Conditions Accepted:</u> The undersigned Proposer declares that before preparing this proposal, he or she has read the Proposal Documents carefully, and that this proposal is made with full knowledge of the kind, quality and quantity of services to be furnished by signing this proposal. Proposer agrees to all conditions contained in the Proposal Documents.





#### FORM OF AGREEMENT FOR SERVICES

and between the Town of Youngtown, Arizona, a municipal corporation, hereinafter referred to as the "Town" and, hereinafter referred to as the "Contractor."
FOR THE PURPOSE of providing services related to the purchase and installation of wrought iron fencing, gates and signage in and around the Town Square for the Town of Youngtown, the Town and Contractor do hereby mutually agree to the following:
1. SERVICES AND RESPONSIBILITIES
1.1 <u>Retention of the Contractor</u> . In consideration of the mutual promises contained in this Agreement, the Town engages the Contractor to render services set forth herein, in accordance with all the terms and conditions contained in this Agreement.
1.2 <u>Scope of Services</u> . The Contractor shall do, perform and carry out in a satisfactory and proper manner, as determined by the Town, the services set forth in this Agreement, including all exhibits ("Services"). The specific scope of work is set forth in Exhibit A.
1.3 Responsibility of the Contractor.
1.3.1 Contractor shall tour the Services site and become familiar with existing conditions, including utilities, prior to commencing the Services and notify Town of any constraints associated with the Services site.
1.3.2 Contractor shall procure and maintain during the course of this Agreement insurance coverage required by Paragraph 4 of this Agreement.
1.3.3 Contractor shall designate as Contractor Representative and all communications shall be directed to him.
1.3.4 Contractor's subcontracts are set forth in Exhibit B attached hereto and made a part hereof. Any modification to the list of Subcontractors on Exhibit B, either by adding, deleting or changing subcontractors, shall require the written consent of the Town.
1.3.5 Contractor shall obtain its own legal, insurance and financial advice regarding Contractor's legal, insurance and financial obligations under this Agreement.
1.3.6 Contractor shall coordinate its activities with the Town's representative

1.3.8 Contractor shall obtain and pay for all business registrations, licenses, permits, governmental inspections and governmental fees necessary and customarily required

regulations all labor, materials, equipment, and transportation, and other facilities and services necessary for the proper execution and completion of the Services. Contractor shall provide

1.3.7 Contractor shall provide, pay for and insure under the requisite laws and

and submit its reports to the Town's representative.

and pay for and insure for all equipment necessary for the Services.

for the proper execution and completion of Services. Contractor shall pay all applicable taxes. Contractor shall give all notices and comply with all laws, ordinances, rules, regulations and lawful orders of any public authority bearing on the performance of the Services.

#### 1.4 Responsibility of the Town.

- 1.4.1 The Town shall cooperate with the Contractor by placing at his disposal all available information concerning the Services.
- 1.4.2 Town designates Marty Mosbrucker, Public Works Manager, as its Town Representative. All communications to Town shall be through its Town Representative.
- 1.5 <u>Contract Term; Renewal.</u> Contract commences upon execution of the Contract. Services shall not commence until issuance of a Notice to Proceed or Purchase Order by Town. All services shall be completed by March 1, 2019. Any intermediate deadlines or milestones are set forth in Exhibit C.

#### COMPENSATION AND METHOD OF PAYMENT

- 2.1 <u>Compensation.</u> All compensation for complete and satisfactory completion of services rendered by Contractor, including its subcontractor(s), shall be set forth in Exhibit D and shall not exceed \$\_\_\_\_\_\_
- 2.2 <u>Method of Payment.</u> Method of payment shall be set forth in Exhibit D. If payment is to be made monthly, Contractor shall prepare monthly invoices and progress reports which clearly indicate the progress to date and the amount of compensation due by virtue of that progress. All invoices shall be for services completed.
- 2.3 <u>Invoices</u>. Town reserves the right to deduct up to ten percent (10%) from the invoiced amount for any invoice submitted more than sixty (60) days after the Services are completed. Invoices for the month of July shall be submitted on or before August 1st. Invoices submitted after the close out of the fiscal year (August 1st) shall not be paid by the Town.
- 2.4 The Contractor shall provide to Town its completed W-9 Form prior to receipt of any Compensation.
- 2.5 <u>Taxes.</u> Contractor will be responsible for and shall pay all sales, consumer, use, and other taxes. When equipment, materials or services generally taxable to the Contractor are eligible for a tax exemption, credit or deduction due to the nature of the item, at Contractor's request, Town will assist Contractor in applying for and obtaining the same.

#### 3. CHANGES TO THE SCOPE OF SERVICES

Change Orders. The Town may, at any time, and by written change order, make changes in the services to be performed under this Agreement. A form of change order is attached hereto as Exhibit E. If such changes cause an increase or decrease in the Contractor's cost or time required for performance of any services under this Agreement, an equitable adjustment shall be made and the Agreement shall be modified in writing accordingly. Any claim of the Contractor for adjustment under this clause must be submitted in writing within thirty (30) days from the date of receipt by the Contractor of the notification of change. It is distinctly understood and agreed by the parties that no claim for extra services provided or materials furnished by Contractor will be allowed by the Town except as provided herein nor shall Contractor provide any services or furnish any materials not covered by this Agreement unless the Town first approves in writing.

#### 4. INSURANCE REPRESENTATIONS AND REQUIREMENTS

- 4.1 <u>General.</u> Contractor agrees to comply with all Town ordinances and state and federal laws and regulations. Without limiting any obligations or liabilities of Contractor, Contractor shall purchase and maintain, at its own expense, hereinafter stipulated minimum insurance with insurance companies duly licensed by the State of Arizona (admitted insurer) with an AM Best, Inc. rating of A-7 or above or an equivalent qualified unlicensed insurer by the State of Arizona (non-admitted insurer) with policies and forms satisfactory to the Town. Failure to maintain insurance as specified may result in termination of this Agreement at the Town's option.
- 4.2 No Representation of Coverage Adequacy. By requiring insurance herein, the Town does not represent that coverage and limits will be adequate to protect Contractor. Town reserves the right to review any and all of the insurance policies and/or endorsements cited in this Agreement but has no obligation to do so. Failure to demand such evidence of full compliance with the insurance requirements set forth in this Agreement or failure to identify any insurance deficiency shall not relieve Contractor from, nor be construed or deemed a waiver of, its obligation to maintain the required insurance at all times during the performance of this Agreement.
- 4.3 Additional Insured. All insurance coverage and self-insured retention or deductible portions, except Workers Compensation insurance and Professional Liability insurance if applicable, shall name, to the fullest extent permitted by law for claims arising out of the performance of this Agreement, the Town, its agents, representatives, officers, directors, officials and employees as Additional Insured as specified under the respective coverage sections of this Agreement.
- 4.4 <u>Coverage Term.</u> All insurance required herein shall be maintained in full force and effect until all Services required to be performed under the terms of this Agreement is satisfactorily performed, completed and formally accepted by the Town, unless specified otherwise in this Agreement.
- 4.5 <u>Primary Insurance</u>. Contractor's insurance shall be primary insurance as respects performance of subject contract and in the protection of the Town as an Additional Insured.

- 4.6 <u>Claims Made.</u> In the event any insurance policies required by this Agreement are written on a "claims made" basis, coverage shall extend, either by keeping coverage in force or purchasing an extended reporting option, for three (3) years past completion and acceptance of the Services evidenced by submission of annual Certificates of Insurance citing applicable coverage is in force and contains the provisions as required herein for the three-year period.
- 4.7 <u>Waiver.</u> All policies, including Workers' Compensation Insurance, shall contain a waiver of rights of recovery (subrogation) against the Town, its agents, representatives, officials, directors, officers, and employees for any claims arising out of the Services of Contractor. Contractor shall arrange to have such subrogation waivers incorporated into each policy via formal written endorsement thereto.
- 4.8 Policy Deductibles and or Self-Insured Retentions. The policies set forth in these requirements may provide coverage, which contain deductibles or self-insured retention amounts. Such deductibles or self-insured retention shall not be applicable with respect to the policy limits provided to the Town. Contractor shall be solely responsible for any such deductible or self-insured retention amount. The Town, at its option, may require the Contractor to secure payment of such deductible or self-insured retention by a surety bond or irrevocable and unconditional Letter of Credit.
- 4.9 <u>Use of Subcontractors.</u> If any Services under this Agreement are subcontracted in any way, the Contractor shall execute written agreement with the Subcontractor containing the same Indemnification Clause and Insurance Requirements set forth herein protecting the Town and the Contractor. The Contractor shall be responsible for executing the agreement with the Subcontractor and obtaining Certificates of Insurance verifying the insurance requirements.
- 4.10 Evidence of Insurance. Prior to commencing any Services under this Agreement, Contractor shall furnish the Town with Certificate(s) of Insurance, or formal endorsements as required by this Agreement, issued by the Contractor's Insurer(s) as evidence that policies are placed with acceptable insurers as specified herein and provide the required coverage's, conditions, and limits of coverage specified in this Agreement and that such coverage and provisions are in full force and effect. Acceptance and reliance by the Town on a Certificate of Insurance shall not waive or alter in any way the insurance requirements or obligations of this Agreement. Such Certificate(s) shall identify the Agreement and be sent to the Town Risk Manager. If any of the above cited policies expire during the life of this Agreement, it shall be the Contractor's responsibility to forward renewal Certificates within ten (10) days after the renewal date containing all the aforementioned insurance provisions. Certificates shall specifically cite the following provisions:
- 4.10.1 Town, its agents, representatives, officers, directors, officials and employees is an Additional Insured as follows:
  - a. Commercial General Liability-Under ISO Form CG 20 10 11 85 or equivalent.
  - b. Auto Liability-Under ISO Form CA 20 48 or equivalent.
  - c. Excess Liability-Follow Form to underlying insurance.
- 4.10.2 Contractor's insurance shall be primary insurance with respect to performance of this Agreement.

- 4.10.3 All policies, including Workers' Compensation, waive rights of recovery (subrogation) against the Town, its agents, representatives, officers, directors, officials and employees for any claims arising out of Services performed by the Contractor under this Agreement.
- 4.10.4 Certificate shall cite a thirty (30) day advance notice cancellation provision. If ACORD Certificate of Insurance form is used, the phrases in the cancellation provision "endeavor to" and "but failure to mail such notice shall impose no obligation or liability of any kind upon the company, its agents or representatives" shall be deleted. Certificate forms other than ACORD form shall have similar restrictive language deleted.

#### 4.11 Required Coverage:

- 4.11.1 Commercial General Liability: The Contractor shall maintain "occurrence" from Commercial Liability Insurance with a policy limit of not less than \$1,000,000 for each occurrence, \$2,000,000 Products and Completed Operations Annual Aggregate, and a \$2,000,000 General Aggregate Limit. The policy shall cover liability arising from premises, operations, independent contractors, products-completed operations, personal injury and advertising injury. Coverage under the policy will be at least as broad as Insurance Services Office, Inc. policy form CG 00 010 93 or equivalent thereof, including but not limited to, separation of insured clause. To the fullest extent allowed by law, for claims arising out of the performance of this Agreement, the Town, its agents, representatives, officers, directors, officials and employees shall be cited as an Additional Insured Endorsement form CG 20 10 11 85 or equivalent, which shall read "Who is an Insured (Section II) is amended to include as an insured the person or organization shown in the Schedule, but only with respect to liability arising out of "your work" for that insured by or for you". If any Excess insurance is utilized to fulfill the requirements of this paragraph, such Excess insurance shall be "follow form" equal or broader in coverage scope than underlying insurance.
- 4.11.2 Professional Liability: The Contractor shall maintain Professional Liability insurance covering errors and omissions arising out of the Services performed by the Contractor, or anyone employed by the Contractor, or anyone for whose acts, mistakes, errors and omissions the Contractor is legally liable, with a liability insurance policy limit of \$1,000,000 each claim and \$2,000,000 all claims. Professional Liability coverage specifically shall contain contractual liability insurance covering the contractual obligations of this Agreement. In the event the Professional Liability insurance policy is written on a "claims made" basis, coverage shall extend for three (3) years past completion and acceptance of the Services, and the Contractor shall be required to submit Certificates of Insurance evidencing proper coverage is in effect as required above.

- 4.11.3 Vehicle Liability: The Contractor shall maintain Business Automobile Liability Insurance with a limit of \$1,000,000 each occurrence on the Contractor's owned, hired, and non-owned vehicles assigned to or used in the performance of the Contractor's Services under this Agreement. Coverage will be at least as broad as Insurance Services Office, Inc., coverage code "1" any auto policy form CA 00 01 12 93 or equivalent thereof. To the fullest extent allowed by law, for claims arising out of performance of this Agreement, the Town, its agents, representatives, officers, directors, officials and employees shall be cited as an Additional Insured under the Insurance Service Offices, Inc. Business Auto Policy Designated Insured Endorsement form CA 20 48 or equivalent. If any Excess insurance is utilized to fulfill the requirements of this paragraph, such Excess insurance shall be "follow form" equal or broader in coverage scope than underlying insurance.
- 4.11.4 Workers' Compensation Insurance: The Contractor shall maintain Workers' Compensation insurance to cover obligations imposed by federal and state statutes having jurisdiction of the Contractor's employees engaged in the performance Services under this Agreement and shall also maintain Employer Liability Insurance of not less than \$500,000 for each accident, \$500,000 disease for each employee and \$1,000,000 disease policy limit.

#### 5. INDEMNIFICATION

- 5.1 To the fullest extent permitted by law, the Contractor, its successors, assigns and guarantors, shall pay, defend, indemnify and hold harmless the Town, its agents, officers, officials and employees from and against all demands, claims, proceedings, suits, damages, losses and expenses (including but not limited to attorney fees, court costs, and the cost of appellate proceedings), and all claim adjustment and handling expenses, relating to, arising out of, or alleged to have resulted from acts, errors, mistakes, omissions, Services caused by the Contractor, its agents, employees or any tier of Contractor's subcontractors related to the Services in the performance of this Agreement. Contractor's duty to defend, hold harmless and indemnify the Town, its agents, officers, officials and employees shall arise in connection with any claim, damage, loss or expense that is attributable to bodily injury, sickness, disease, death, or injury to, impairment, or destruction of property including loss of use of resulting therefrom, caused by Contractor's acts, errors, mistakes, omissions, Services in the performance of this Agreement including any employee of the Contractor, any tier of Contractor's subcontractor or any other person for whose acts, errors, mistakes, omissions, Services the Contractor may be legally liable including the Town. Such indemnity does not extend to the Town's negligence.
- 5.2 Insurance provisions set forth in this Agreement are separate and independent from the indemnity provisions of this paragraph and shall not be construed in any way to limit the scope and magnitude of the indemnity provisions. The indemnity provisions of this paragraph shall not be construed in any way to limit the scope and magnitude and applicability of the insurance provisions.

#### 6. TERMINATION OF THIS AGREEMENT

6.1 <u>Termination</u>. The Town may, by written notice to the Contractor, terminate this Agreement in whole or in part within seven (7) days' notice, either for the Town's convenience or because of the failure of the Contractor to fulfill his contract obligations. Upon receipt of such notice, the Contractor shall: (1) immediately discontinue all services affected (unless the notice directs otherwise), and (2) deliver to the Town copies of all data, drawings, reports, estimates, summaries, and such other information and materials as may have been accumulated by the Contractor in performing this Agreement, whether completed or in process. This Agreement

may be terminated in whole or in part by the Contractor in the event of substantial failure by the Town to fulfill its obligations.

6.2 <u>Payment to Contractor Upon Termination</u>. If the Agreement is terminated, the Town shall pay the Contractor for the services rendered prior thereto in accordance with the percent of completion at the time work is suspended minus previous payments.

#### 7. ASSURANCES

- 7.1 Solicitations for Subcontractors, Including Procurements of Materials and Equipment. In all solicitations either by competitive bidding or negotiation made by the Contractor for Services to be performed under a subcontract, including procurements of materials or leases of equipment, each potential subcontractor or supplier shall be notified by the Contractor of the Contractor's obligations under this Agreement and any Regulations relative to nondiscrimination on the grounds of race, color or national origin.
- 7.2 <u>Examination of Records</u>. The Contractor agrees that duly authorized representatives of the Town shall, until the expiration of three (3) years after final payment under this Agreement, have access to and the right to examine any directly pertinent books, documents, papers, and records of the Contractor involving transactions related to this Agreement.
- 7.3 Ownership of Document and Other Data. Original documents and other data prepared or obtained under the terms of this Agreement or any change order are and will remain the property of the Town unless otherwise agreed to by both parties. Town may use such documents for other purposes without further compensation to the Contractor; however, any reuse without written verification or adaptation by Contractor for the specific purpose intended will be at the Town's sole risk and without liability or legal exposure to Contractor. Any verification or adaptation of the documents by Contractor for other purposes than contemplated herein will entitle Contractor to further compensation as agreed upon between the parties.
- 7.4 <u>Litigation</u>. Should litigation be necessary to enforce any term or provision of this Agreement, or to collect any damages claimed or portion of the amount payable under this Agreement, that all litigation and collection expenses, witness fees, court costs, and reasonable attorneys' fees incurred shall be paid to the prevailing party.
- 7.5 Independent Contractor. This Contract does not create an employee/employer relationship between the parties. It is the parties' intention that the Contractor will be an independent contractor and not the Town's employee for all purposes, including, but not limited to, the application of the Fair Labor Standards Act, Federal Insurance Contribution Act, the Social Security Act, the Federal Unemployment Tax Act, the Internal Revenue Code, the Immigration and Naturalization Act, Arizona revenue and taxation laws, Arizona Workers' Compensation Law, and Arizona Unemployment Insurance Law. The Contractor agrees that it is a separate and independent enterprise from the Town, that it has a full opportunity to find other business, that it has made its own investment in its business, and that it will utilize a high level of skill necessary to perform the work. This Contract shall not be construed as creating any joint employment relationship between the Contractor and the Town, and the Town will not be liable for any obligation incurred by the Contractor, including but not limited to unpaid minimum wages and/or overtime premiums. [FOR SOLE PROPRIETORS ONLY: The Contractor shall execute the Sole Proprietor's Waiver of Workers' Compensation Benefits attached hereto and incorporated by reference.]

- 7.6 Immigration Law Compliance Warranty. As required by A.R.S. § 41-4401. Contractor hereby warrants its compliance with all federal immigration laws and regulations that relate to its employees and A.R.S. § 23-214(A). Contractor further warrants that after hiring an employee, Contractor verifies the employment eligibility of the employee through the E-Verify program. If Contractor uses any subcontractors in performance of the Work, subcontractors shall warrant their compliance with all federal immigration laws and regulations that relate to its employees and A.R.S. § 23-214(A), and subcontractors shall further warrant that after hiring an employee, such subcontractor verifies the employment eligibility of the employee through the E-Verify program. A breach of this warranty shall be deemed a material breach of the Contract that is subject to penalties up to and including termination of the Contract. Contractor is subject to a penalty of \$100 per day for the first violation, \$500 per day for the second violation, and \$1,000 per day for the third violation. The Town at its option may terminate the Contract after the third violation. Contractor shall not be deemed in material breach of this Contract if the Contractor and/or subcontractors establish compliance with the employment verification provisions of Sections 274A and 274B of the Federal Immigration and Nationality Act and the E-Verify requirements contained in A.R.S. § 23-214(A). Town retains the legal right to inspect the papers of any Contractor or subcontractor employee who works on the Contract to ensure that the Contractor or subcontractor is complying with the warranty. Any inspection will be conducted after reasonable notice and at reasonable times. If state law is amended, the parties may modify this paragraph consistent with state law.
- 7.7 <u>Exclusive Use of Services Confidentiality</u>. The services agreed to be provided by Contractor within this Agreement are for the exclusive use of the Town and Contractor shall not engage in conflict of interest nor appropriate Town work product or information for the benefit of any third parties without Town consent.
- 7.8 <u>Sole Agreement</u>. There are no understandings or agreements except as herein expressly stated.
- 7.9 <u>Notices</u>. Any notice to be given under this Agreement shall be in writing, shall be deemed to have been given when personally served or when mailed by certified or registered mail, addressed as follows:

The address may be changed from time to time by either party by serving notices as provided above.

7.10 <u>Controlling Law</u>. This Agreement is to be governed by the laws of the State of Arizona.

#### 8. SUSPENSION OF WORK

8.1 <u>Order to Suspend</u>. The Town may order the Contractor, in writing, to suspend all or any part of the Services for such period of time as he may determine to be appropriate for the convenience of the Town.

8.2 Adjustment to Contract Fee. If the performance of all or any part of the Services is, for any unreasonable period of time, suspended or delayed by an act of the Town in the administration of this Agreement, or by its failure to act within the time specified in this Agreement (or if no time is specified, within a reasonable time), an adjustment shall be made for any increase in cost of performance of this Agreement necessarily caused by such unreasonable suspension or modified in writing accordingly. However, no adjustment shall be made under this clause for any suspension or delay to the extent (1) that performance was suspended or delayed for any other cause, including the fault or negligence of the Contractor, or (2) for which an equitable adjustment is provided for or excluded under any other provision of this Agreement.

#### 9. INTERESTS AND BENEFITS

- 9.1 <u>Interest of Contractor.</u> The Contractor covenants that he presently has no interest and shall not acquire any interest, direct or indirect, which would conflict in any manner or degree with the performance of services required to be performed under this Agreement. The Contractor further covenants that in the performance of this Agreement, no person having any such interest shall be employed.
- 9.2 <u>Interest of Town Members and Others.</u> No officer, member or employee of the Town and no member of its governing body, who exercises any functions or responsibilities in the review or approval of the undertaking or carrying out of the services to be performed under this Agreement, shall participate in any decision relating to this Agreement which affects his personal interest or have any personal or pecuniary interest, direct or indirect, in this Agreement or the process thereof.
- 9.3 <u>Notice Regarding A.R.S. § 38-511</u>. This Contract is subject to cancellation under Section 38-511, Arizona Revised Statutes.

#### 10. ASSIGNABILITY

The Contractor shall not assign any interest in this Agreement, and shall not transfer any interest in the same without the prior written consent of the Town thereto.

#### 11. ISRAEL

Licensor certifies that it is not currently engaged in, and agrees for the duration of this Agreement that it will not engage in, a boycott of Israel, as that term is defined in Ariz. Rev. Stat. § 35-393.

# EXHIBIT A SCOPE OF WORK

- 1. **Description.** Furnish and install wrought iron fences and gates including gate controller and loops at locations shown on the plans. The workmanship will be prescribed by this special specification, in conformity with details shown on the plans and/or as directed/approved by the Public Works Manager.
- 2. Materials. Furnish new materials in accordance with the details shown on the plans. The materials for the fence include 16-inch x 8-inch masonry columns, rails, columns caps and all necessary fittings and appurtenances required for proper installation. The materials for the gate will be gate controllers, loops and all necessary fittings and appurtenances required for the installation of the gate. The material for the communication cables will meet all the requirements of NEC and be a minimum of AWG No. 22 and meet or exceed the specification of CAT 5 cables. The Contractor will provide the Public Works Manager with the specifications of all items for the fence and gates for approval before installation. See Exhibit 2, samples of the gate and fencing being requested.

The Town is requesting a bid to install an automated remote controlled/keypad operated gate to the employee parking area along with a personnel gate with key pad.

3. Construction. Before work commences in the area, the Contractor will inform and inspect the site with the Public Works Manager. After the construction is complete, the Contractor will again inspect the site with the Public Works Manager for approval.

All the material for the new wrought iron (16 gauge with 3/8" pattern) fence panels will be first approved by the Public Works Manager. The new fence will include but not be limited to columns, stucco paint, skip trowel and smooth finish. The concrete footing for the new columns will be as shown on the plans and/or as directed by the Public Works Manager.

Painting will be by hand or spray. Two coats will be required on all parts. The final surface will be of even color without streaks, drips, bubbles, incomplete coverage or any other surface imperfection.

If necessary, the fence will be reinforced at the joints with either welding or welded on metal that will not detract from the decorative appeal of the fence. All welding will be performed in a workman-like manner with solid joints of minimum protrusion. The completed fence will be solid and have minimal flexure. Any excessive splatter of the weld will be ground off.

The Contractor will install a new manual gate(s) and all necessary fittings and appurtenances as shown on the plans and/or as directed by the Public Works Manager.

The Contractor will pull through new conduit without splicing all necessary communication cables from card reader into the control center as shown on the plans and/or as directed by the Public Works Manager.

The Contractor shall provide/install "Public Parking" sign per Exhibit "1".




